Agenda item #1- General Business

Commissioner Clark made the motion to approve the report of the Tax Assessor/Collector. Commissioner Lynn Smith seconded. All voted for. Motion carried.

Commissioner Smith made the motion to approve the reports from J.P. #1, Pl.1, County Attorney's Office, County Extension Agent's office and County Clerk's office. Commissioner Clark seconded. All voted for. Motion carried.

Commissioner Lynn Smith made the motion to waive the agenda to let the representatives from TNRCC address the Court. Commissioner Clark seconded. All voted for. Motion carried.

Three representatives from the BEaumont office of the TNRCC met with the Court to discuss the possibility of the County appointing a designated representative to help in the area of the installing and inspecting of septic systems. There would not be any monetary compensation from the state for this person. He would be paid through the County. A resonable fee could be charged for inspecting sewer systems to off set the salary of this person. It is illegal to install a sewer system if the installer is not a registered installer. This is believed to be a problem by members of the Court. There was no action taken on this agenda item.

This is actually to create the position of a County Coordinator for 911. This will be a paid position. The salary will be the same as a chief deputy in the Courthose is paid. The County would not be reimbursed for the insurance, social security, retirement and withholding tax. Commissioner Lynn Smith informed the Court that Bob Smiley with the Forest Service, told him that the Forest Service has some cattleguards that the County can have if they want them. The County would have to repair the road when they take the cattleguards up. Commissioner Lynn Smith told the Court that if they wanted some of them, Mr. Smiley would have to be contacted so that the paper work could be done. Commissioner Clark is to contact Mr. Smiley.

Agenda item #8- Appointment of Judge Pro-tem for Commissioners' Ct. At this time, Judge Pro-tem, Commissioner Cox, read his letter of resignation as Judge Pro-tem for Commissioners' Court.

Dear Sir;

Sabine County has approved a plan for the development of an expandable addressing system in this County. The County has adopted certain standards which will be observed in the implementation of this plan. The County has provided for the hardware and software associated with the creation and use of a Geographical Information System (GIS) for data which is unique to this County. And, most recently, the County has approved a proposal whereby structures (residential and commercial) will be assigned addresses and "captured" into a data base along with identification and attribute data for each address assigned. This information will be used initially to complete the implementation of an Enhanced 9-1-1 System in Sabine County. In addition to the above, the county will have the ability to produce maps indicating a geographical representation of each structure which has been captured, political boundaries, school districts, telephone exchange boundaries, USPS boundaries and local post office delivery routes, jurisdictions for fire, EMS and law enforcement respondents, Emergency Service Zones, and major landmark features such as hydrology, railroads, power and pipeline ROW's, etc. Simply put, this project will yield much valuable information for Sabine County and provide easy access to the data collected.

To ensure that maximum benefits are realized from the efforts of the Sabine County ADR (911) Project, and that the development of the GIS is monitored sufficiently to obtain desired results it is my opinion that the County should create a position within its structure to be known as <u>Sabine County 911 Project</u> <u>Coordinator</u>. This position would be equivalent to a Chief Deputy position and would be responsible for the day to day operations required by the project. The 911 Project Coordinator would also be responsible for the coordination and delivery of contracted for services, training and oversight throughout the extent of this project. This position would be responsible directly to the Commissioners Court.

As you are aware, this is a very inclusive and complex project. Its success will be measured only by what we can do with the results.

Your consideration of creating the above described position will be appreciated.
