



Commissioners Clark and Lynn Smith were not present.

Judge Hyden called the meeting to order at 2:06 P.M., notice was duly posted.

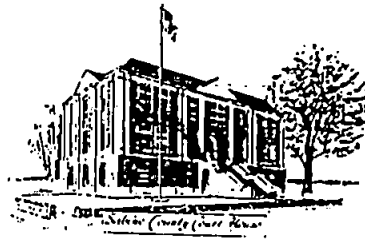
.Agenda item #1-Budget Workshop: R&B


Dear Mr. Slacum:
