This letter is sent to you as the Responsible Court Representative for the Sabine County 9-1-1 Addressing Project to seek Court approval of the purchase of required materials and equipment to meet the objectives of the Sabine County 9-1-1 Addressing Project with regards to street signage. Reference is made to the Structure Numbering Resolution passed by the Commissioners Court in November of 1993 wherein the requirements for street signs and their placement is described in the "Signage" section of Attachment # 1. The following recommendation is based upon those standards set forth in the attachment and in the opinion of the writer would best suit the needs of the County.

The quantities suggested below are based upon estimates provided by the Sabine County 9-1-1 Administration office and are believed to be a reasonable for purposes of beginning the sign placement phase of the addressing project. The actual number of street signs and poles required to provide complete signage for all roadways of the county is not determinable at this time. It will suffice to say that more will be needed as the project progresses. Factors which will influence the quantities include future development of the county and the extent to which the County desires to provide signage in the "subdivision" areas.

The cost estimates are the result of a comparison effort. The supplier providing the lowest cost has been selected for use in this recommendation. All cost projections are excluding freight and taxes, if applicable.

It is suggested that the Court move immediately to secure the Gerber Signer Package. A Signer is currently being held at the discounted price, as indicated, but we must execute the order promptly. The items listed with an (*) can be further negotiated if the Court desires.
