Agenda item #1-Transfer Local Registrar from JP #1 to County Clerk

County Clerk, Janice McDaniel, and JP #1, Thomas Hamilton, met with the Court to request that the position of Local Registrar be transferred from Justice of the Peace #1 to the County Clerk.

Janice told the Court that she has received information from the Bureau of Vital Statistics about going on line with them. You have to be the local registrar to do this. It was agreed between Janice and Thomas to transfer the position with the agreement of the Court.

If the Bureau approves us, we can issue birth certificates for anyone born in the State of Texas. There are several steps we must take to get this accomplished and will take two or so months, but it will be worth it.

Judge Leath moved to appoint the County Clerk as the local registrar. Commissioner Clark seconded. All voted for. Motion carried. See attached order of the Court.

Commissioner Dickerson moved to adjourn. Commissioner Lynn Smith seconded. Meeting adjourned.
