Agenda item #1-Discuss & Possible Take Action—Brazos Transit System Judge Leath read a letter from Mr. Lyle M. Nelson, Assistant General Manager of the Brazos Transit System. He said he has contacted Mr. Nelson's office and has not received a call back from Mr. Nelson. Judge Leath said he wanted to have him present in Court today to make a presentation. While service within the County will be open scheduled, service to destinations outside of the County will be scheduled express service. An example would be service to Angelina College and other Lufkin locations would leave Hemphill at approximately 7:00 a.m. in order to access 8:00 a.m. classes, doctor's appointments or work schedules.
