The buses will be housed in Lufkin at this time and may be housed here later if the routes require it. The cost to the County is \$12,000.00 with a minimum of a 2-year contract or agreement.

Judge Leath said the Court would like to look over the agreement before a decision is made.

Mr. Nelson said he would fax the agreement to the Judge.




