

PREAMBLE

1. Petitioners representing at least 50 of the electors who own land in a proposed freshwater supply district (the "District") have previously presented to this Commissioners Court (the "Governing Body") of Sabine County, Texas (the "County") a petition (the "Petition") requesting creation of the District under Texas Water Code chapter 53.

2. The Governing Body had reviewed the Petition and confirmed that the signatories thereto represent at least 50 of the electors residing in the proposed District who own land in the proposed District.

3. On January 31, 2002, Governing Body held a hearing to concerning creation of the District. Pursuant to the authority granted to it pursuant to section 53.019(b), Texas Water Code, the Governing Body desires that the hearing be reopened and that certain matters concerning creation of the District be re-heard.

NOW, THEREFORE, BE IT ORDERED THAT

SECTION 1. Time and Place of Hearing.

The prior hearing held by the Governing Body shall be reopened and a rehearing (the *"Hearing"*) on the Petition shall be held on [3-7-02], in the Commissioners Courtroom, County Courthouse, Hemphill, Texas, at [7PM].

SECTION 2. Notice.

The County Clerk shall issue notice (the "Notice") of the time and place of the Hearing in substantially the form attached hereto as Exhibit A, which notice shall include a statement that any person is entitled to appear at the Hearing, challenge the form and allegations of the Petition, and contest the proposition that the projects to be undertaken by the proposed District would benefit the land inside its boundaries. The County Clerk shall maintain a copy of the Petition on file, and prior to the hearing shall make copies of the Petition available to any person requesting the Petition.

The County Clerk may deliver the Notice to any adult who is willing to execute it as directed by section 53.018, Texas Water Code The person receiving the Notice shall post a copy of it at the courthouse door and a copy at each of four different places inside the proposed District. The Notice shall be posted for at least the 10 days that immediately precede the day set for the hearing.

The person posting the Notice shall swear in writing, before an officer authorized by law to administer oaths, that he posted the notice according to the provisions of section 53.018(a), Texas Water Code.

SECTION 3. Hearing Powers.

The Governing Body shall have jurisdiction to determine all issues pertaining to the sufficiency of the Petition and shall allow any interested person to appear before it in person or by attorney to offer testimony relative to the sufficiency of the Petition. The Governing Body may adjourn the Hearing from day to day as is necessary to complete the Hearing. The Commissioners Court may make all orders necessary to determine the matters before it.

SECTION 4. Recitals.

The section headings herein are for convenience only and shall not affect the construction hereof.

The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part hereof for all purposes and are adopted as part of the judgment and findings of the Governing Body.

SECTION 5. Actions by County Judge and County Clerk.

The County Judge and County Clerk of the County are hereby authorized to evidence adoption of this Order and directed to do any and all things legal and necessary in connection with the holding and consummation of the hearing and to carry out the intent hereof.
