Judge Leath called the hearing to order at 7:00 p.m.

Judge Leath told the people present that the boundaries of the proposed Water District have not been completely established on paper. El Camino Water Supply District dropped out so now new boundaries have to be drawn. If the boundaries had been completed, the Court would either accept the petition and appoint an interim Board of Directors or reject the petition and that would be the end of it. If everything proceeds and a temporary Board of Directors is appointed, that Board would then call for an election. It would then be up to the voters of the District. He said the Engineer that is over the plans for the District has another engagement and could not be here. Questions will be taken and the Court will answer them to the best of our ability.

Some of the questions asked are as follows:

- Q- Was the petition a complaint about the water quality?
- A- The petition was for the creation of a Fresh Water Supply District. If a District is formed, we will be able to get lower interest rates than what you would get on the open market because it will be a governmental subdivision.
- Q- Does money the SRA gets from selling water go into the County's general fund?
- A- The SRA has their own budget and finances. No money from the SRA goes Into the County's budget. The SRA leases the water plant to the City of Hemphill and G-M buys water from the City of Hemphill.
- Q- If the District is voted down, will be just have to live with the quality of water we get from G-M?
- A- G-M would continue to operate as they are now but we don't know for how long. They are under order of the TNRCC to bring the system up to minimum standards.

- Q- I understand that the cost would be from 7 to 17 dollars more than it is right now. How are senior citizens and people on fixed incomes going to afford that?
- A- We don't know how people will afford the price increase but the cost is going up anyway whether it is from the Water District or G-M having to borrow money for the ordered improvements.
- Q- How much does G-M pay the City of Hemphill for water?
- A- Don Iles said that G-M only pays what it cost the City to produce it.
- Q- Would the same employees working for G-M now be working for the District?
- A- That would be up to the Board of Directors.

Judge Leath said if the boundaries get done and we meet the time line, the election will be held May 4, 2002.

Judge Leath moved that the Commissioners' Court adopt the Order Adjourning Hearing For Petition Requesting Creation of Freshwater Supply District to March 14, 2002; And Redrawing Boundaries by which this hearing shall be adjourned until March 14, 2002, and the boundaries of the proposed District shall be redrawn as set forth in the Order. Commissioner Smith seconded. All voted for. Motion carried.

Commissioner Nethery moved to adjourn. Commissioner Dickerson seconded. Meeting adjourned until March 14, 2002.



PREAMBLE

1. Petitioners representing at least 50 of the electors who own land in a proposed freshwater supply district (the "District") have previously presented to this Commissioners Court (the "Governing Body") of Sabine County, Texas (the "County") a petition (the "Petition") requesting creation of the District under Texas Water Code chapter 53.

2. The Governing Body had reviewed the Petition and confirmed that the signatories thereto represent at least 50 of the electors residing in the proposed District who own land in the proposed District.

3. On January 31, 2002, Governing Body held a hearing to concerning creation of the District. Pursuant to the authority granted to it pursuant to section 53.019(b), Texas Water Code, the Governing Body desires that the hearing be reopened and that certain matters concerning creation of the District be re-heard.

4. On February 15, 2002, the Governing Body ordered that the prior hearing held by the Governing Body be reopened and a rehearing (the "*Hearing*") on the Petition be held on March 7, 2002, in the Commissioners Courtroom, County Courthouse, Hemphill, Texas.

5. The Governing Body now desires that the Hearing be adjourned until March 14, 2002, when the Hearing shall be reopened in the Commissioners Courtroom, County Courthouse, Hemphill, Texas.

6. Based on testimony received at the hearing and other information before the Governing Body, the Governing Body further desires that the boundaries of the proposed District be redrawn to exclude the extraterritorial jurisdiction of the Cities of Pineland and Hemphill, and the Pendleton Harbor, Frontier Park, and El Camino Bay service areas.

NOW, THEREFORE, BE IT ORDERED THAT

SECTION 1. Time and Place of Hearing

Pursuant to Texas Water Code section 53.018, the Hearing is adjourned until March 14, 2002, when the Hearing shall be reopened in the Commissioners Courtroom, County Courthouse,

SECTION 2. Boundaries.

Pursuant to Texas Water Code section 53.019(b), the Governing Body orders that the boundaries of the proposed District be redrawn to exclude the extraterritorial jurisdiction of the Cities of Pineland and Hemphill, and the Pendleton Harbor, Frontier Park, and El Camino Bay service areas.

SECTION 3. Hearing Powers

The Governing Body shall have jurisdiction to determine all issues pertaining to the sufficiency of the Petition and shall allow any interested person to appear before it in person or by attorney to offer testimony relative to the sufficiency of the Petition. The Governing Body may adjourn the Hearing from day to day as is necessary to complete the Hearing. The Commissioners Court may make all orders necessary to determine the matters before it.
