In discussion, Commissioner Smith said he is not for a tax increase unless it is necessary and he does not think it is necessary at this time.


Commissioners Clark, Dickerson and Nethery and Judge Leath voted for. Commissioner Smith voted against. Motion carried.






Judge Leath moved to approve the Certified Appraisal Roll.

attached copy.


Commissioner Nethery moved to adjourn. Commissioner Dickerson

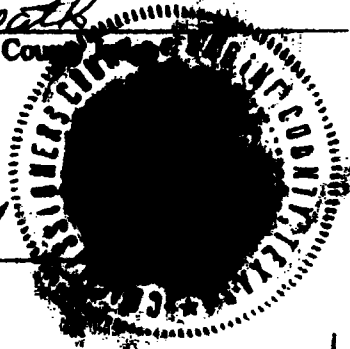
