Judge Pro-tem Smith said actually have 3 different kinds of so-called County roads. One kind is roads that actually belong to the County and are described by metes and bounds. The second kind is roads that are called County roads but in fact are public roads with County maintenance. The third kind is public roads that are not maintained by the County. For the record, we are trying to establish the status of these roads inside of this subdivision. This subdivision is located in precinct 1.

Commissioner Clark said he has been Commissioner of precinct 1 since 1993 and worked for the County since 1983. These roads have been maintained by the County since then.

Millard Vaughn said that there are 3 classes of roads. They are first, second and third class according to the Transportation code, section 251.007, chapter 251. He said he has a map that came from the government that



shows the road goes all the way to the end. These are public roads and have been public roads. According to a deed to a Mr. Haglar, the road has a 40-foot right-of-way. There is also another road leading to Busby's camp house that leads to the water's edge. The date was 1971. By law these roads are to be free of obstruction and they are not.

Judge Pro-tem Smith said we are trying to establish the status of these roads. He asked if anyone in the Courtroom differed with the opinion that these roads are public roads. No one spoke against these roads being subject roads.

Mr. Vaughn said he has copies of all the deeds inside the subdivision and they all refer to 40-foot right-of-ways for the roads.

Bobby G. Ener told the Court that he has owned his property since 1978 and the County has maintained the road since he has been there.

Denis and Kathy Rice are not present. See attached copy of participation form.

Ginger Peet is not present. See attached copy of participation form.

Billy and Bertha Morrision are not present. See attached copy of participation form.

John P. and Joan McGee are present. See attached copy of participation form.

Leonard Lyons is not present. See attached copy of participation form.

Melva Long is not present. See attached copy of participation form. Gladys Tatom stated she is for the County maintaining the roads.

Wm. Eugene Tatom said the County started maintenance on these roads in 1971. Betty Mae Busby McGraw told him that they reserved the road for themselves where his property starts to the water. Their intention was for a public boat ramp. She said they went to the SRA and relinquished their right to a public boat ramp later. Eugene said the County maintenance did not include this portion of the road. He said according to the SRA, this portion of the road reverted back to the adjacent landowners.

A. A. Jamison said he is for public road with County maintenance.

Mr. Vaughn said he has not found any plats on the subdivision. He said on several of the deeds the roads are referred to as County roads.

Judge Pro-tem Smith said that within our County most of the old dirt roads are commonly known as County roads. Some of these roads, we cannot go back in the records and tell when they started. We do not have metes and bounds on them.

Commissioner Clark said these roads have never been to Commissioners' Court to be approved or disapproved. The County has maintained just the roads prior to 1981. No right-of-ways were maintained. This automatically makes them public roads with County maintenance. He said there are no obstructions in the roads.

The Court adjourned the public hearing to go back into regular session.
