

Monday, April 11, 2005, the Sabine County Commissioners' Court met in regular session. The following members were present:

This Court meeting was held in the District Courtroom.

Judge Leath called the meeting to order and Commissioner Dickerson led the Court in prayer.

Judge Leath welcomed the West Sabine Senior Class and introduced the Court. He gave a brief description of the workings of the Court.

Agenda item #1-General Business

Commissioner Clark moved to approve the minutes as written for the March 28th regular and April 5th special sessions of Court. Commissioner Smith seconded. All voted for. Motion carried.

Agenda item #2-Line Item Transfers

No line item transfers were submitted.

Agenda item #4-Declare April 15th as Relay for Life American Cancer Society Day

Commissioner Dickerson moved to declare April 15th as Relay for Life American Cancer Society Day. Commissioner Warner seconded. All voted for. Motion carried.

Agenda item #11-Take Action on Resolution/Request Attachment to Senate Bill 1741

Judge Leath moved to adopt this Resolution. Commissioner Smith seconded. All voted for. Motion carried. See attached copy.

Agenda item #5-Take Action on Resolution for Groundwater Conservation District

Commissioner Smith said from what he gathered from the meeting on April 5th, he feels we need to just wait and keep abreast of what the State does.

No action was taken.

Agenda item #6-Take Action on Insurance Except Health

Handwritten initials and number: "461" with scribbles.

Judge Leath told the Court that TAC did come down from 52 thousand (\$52,000) to about 32 thousand (\$32,000) on the cost for the public officials liability insurance. He said what we want to know is if it will come back down to the 24 thousand (\$24,000) area or not. We do not have an answer to that yet. We are considering self insurance and that may be fine if we don't have any lawsuits for about 10 years to build up revenue. There is no guarantee of that. He recommended that we approve all the other proposals from TAC and make a decision on the public officials coverage at our next regular Court session.

Judge Leath moved to approve all the insurance proposals from TAC except the public officials liability. Commissioner Clark seconded. All voted for. Motion carried.

Agenda item #7-Millard Vaughn to Address Court on 115C Road
Judge Leath told Mr. Vaughn that they would give him 5 minutes.

Mr. Vaughn discussed how he has determined that the road has been changed to a 60-foot right-of-way.

No action was taken by the Court.

Agenda item #8-Request Proposal for Various Construction Stages on the Records Building

Commissioner Clark moved to advertise for proposals for various construction stages on the building for storing records. Commissioner Warner seconded. All voted for. Motion carried.

Agenda item #10-Present Certificate of Completion to Donna Buffalo Tax Assessor/Collector, Tammy Reeves, presented her deputy Donna Buffalo with a certificate of completion. Tammy told the Court that Donna scored 100 on the test and she is very proud of her.

No action was taken by the Court.

Agenda item #9-Take Action on HAVA Resolution

This is the Help America Vote Act. All Counties in the State of Texas is required to have election equipment that is HAVA compliant by January of 2006. The County has to apply for Federal grant funding and meet the requirements for the funding.

Commissioner Smith moved to adopt the HAVA Resolution. Commissioner Clark seconded. All voted for. Motion carried. See attached copy.


BE IT THEREFORE RESOLVED the Commissioners' Court of Sabine County urges the Texas Legislative to include in any legislation the requirement that Sabine River Authority invest a portion of the proceeds from such water sales be invested in recreational facilities on Toledo Bend Reservoir in the counties bordering the lake.




