The Sabine County Commissioners Court is accepting sealed proposals on behalf of Sabine County, Texas for materials and labor to construct a 2940 square foot building. Proposals must be sealed and addressed and delivered to Sabine County Commissioners Court, P. O. Box 716, Hemphill, Texas 75948 on or before ~~9:00~~ a.m. on ~~June 31~~, 2005. Proposals should be submitted separately for the following:

- 1.) Form materials and labor to pour concrete for a 2940 square foot building.
- 2.) Labor only – erect metal building on finished slab.
- 3.) Labor only – stack masonry blocks for said building.
- 4.) Labor only – wire building for electric and install A/C units.
- 5.) Material only – approximately 70 cubic yards concrete
 - reinforcing steel
 - polyethylene
 - approximately 2800 masonry blocks
 - masonry cement
 - metal structure and roof for said building
 - insulation
 - 600 square foot ceiling tile
 - double 3' x 6' 8" glass door unit
 - 3 – 4' x 6' 8" metal door units
 - 2 – 3' x 5' windows
 - 2 air conditioning units
