



Judge Leath called the meeting to order.


Agenda item #1-Emergency Declaration

DECLARING A LOCAL STATE OF DISASTER


WHEREAS, the County of Sabine on the 24<sup>th</sup> day of September, 2005 has suffered widespread or severe damage, injury, or loss of life or property (or there is imminent threat of the same) resulting from Hurricane Rita, and;

WHEREAS, the mayor of the County of Sabine has determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property;


NOW, THEREFORE, BE IT RESOLVED BY THE SABINE COUNTY JUDGE:

- 1) That a state of disaster is declared for the County of Sabine.
- 2) That the Sabine County's Emergency Management Plan has been implemented.
- 3) That this state of disaster shall continue for a period of not more than seven days of the date hereof, unless the same is continued by consent of the Commissioner's Court of Sabine County, Texas.
- 4) That this resolution shall take effect immediately from and after its issuance.
