Judge Leath called the meeting to order.


Agenda item #1-Take Action on Construction Permit Order

Judge Leath said this ordinance was recommended by Jimmy Badgett and other individuals.


Commissioner Warner moved to adjourn. Commissioner Dickerson seconded. All voted for. Meeting adjourned.





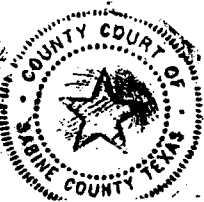

- (9) Don't be rushed into a contract
- (10) If you are suspicious of the contractor or vendor contact the Sheriff's Department.
