Martha Stone, Tax Assessor, stated that Sabine County has the lowest tax rate of our surrounding Counties.

Commissioners Dickerson and Warner said they agree also. The increase in cost for equipment and road material has about doubled in the last few years.

Judge Watson moved to increase the tax rate by 1 cent to .40142. Commissioner Dickerson seconded. All voted for. Motion carried.
