We have \$57,781.78 in carry over funds that can still be allocated. She said this money needs to be dispersed while we still can say where it goes.

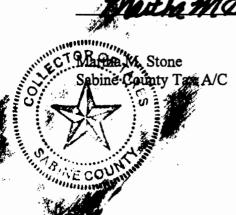

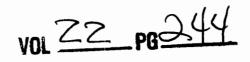

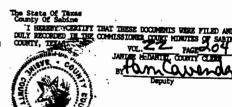
