It was a pleasure to speak with you yesterday. Please find attached the Xerox proposal for replacing the 5 machines in which the leases are coming up for renewal. This pricing proposal is for a 60 month term and includes a pooled allowance of 28,500 copies.

The pricing for this 60 month lease is \$618.61. The pricing for a 48 month lease is \$680.32. In contrast, you are currently paying approximately \$563 on a 48 month lease with a promotional contract that is no longer available.

In speaking with the end users of the machines, the Sherriff's office would like to add the network printing feature to their machine. That feature would add approximately \$30/month to the lease. Adding this feature would be a potential cost savings by not having to purchase costly supplies for the laser printer that sits on a table next to the machine.

This pricing proposal is for replacing the machines now. If you wish to delay the installation until August or September, the pricing would be reduced by approximately \$20/month.

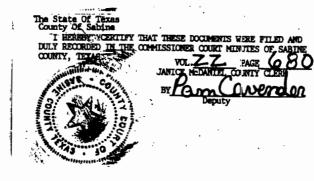
