**DECLARATION OF LOCAL DISASTER** ORDER PROHIBITING OUTDOOR BURNING & PROHIBITING THE SALE AND USE OF FIREWORKS

IN UNINCORPORATED AND INCORPORATED AREAS OF **SABINE COUNTY** 

WHEREAS, the Commissioners' Court of Sabine County, on this 19<sup>th</sup> day of June, 2011, has determined that Sabine County, has been affected by recent wildfires and continues to be threatened by high or extreme wildfire hazard. Sabine County has not had rainfall for an extended period of time, creating hot and dry conditions. This threat is caused by abundant fuel and extreme dry and windy conditions in Sabine County, and;

WHEREAS, the Commissioners' Court of Sabine County has determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property.

NOW THEREFORE, in accordance with the authority vested in the Sabine County Commissioners' Court by Section 418.108 and 418.014 of the Texas Government Code, the Court does hereby proclaim the existence of such disaster and direct that all necessary measures both public and private as authorized by the laws of the State of Texas be implemented to meet that disaster.

- 1. That a local state of disaster is hereby proclaimed for Sabine County pursuant to Section 418.018 (a) of the Texas Government Code.
- 2. Pursuant to Section 418.018 (b) of the Government Code, this Declaration of a local state of disaster shall continue for so long as such conditions exist with the exception granted to fireworks under Section 418.108 (i) of the Government Code which has been ratified by the Governor of the State of Texas and extended through 7 a.m. on July 5, 2011.
- 3. Pursuant to Section 418.018 (d) of the Government Code, this Declaration of a local state of disaster activates the Sabine County Emergency Management Plan.
- 4. The purpose of this order is the mitigation of the hazard posed by wildfires by curtailing the practice of outdoor burning and the sale and use of all fireworks, which purpose is to be taken into account in any enforcement action based upon this order.

BE IT THEREFORE ORDERED that the following emergency regulations are hereby established for all unincorporated and incorporated areas of Sabine County, Texas for the duration of the declaration;

(a) All outdoor burning

(b) The sale and use of all fireworks

**BE IT ALSO ORDERED** that this order may be enforced by any duly-commissioners peace officer and that the venue for prosecution of this order will be the Justice of the Peace Court, Sabine County, Texas.

This Declaration and Order shall take effect immediately from and after its issuance and continue until the conditions requiring this declaration and order are over, with the exception granted to fireworks under Section 418.018 (i) of the Government Code which has been ratified by the Governor of the State of Texas and has extended the restrictions through 7 a.m. on July 5, 2011. (See Exhibit A)

This declaration shall be promptly publicized and filed with the County Clerk.
