RECOMMENDATIONS OF THE TOURISM COMMITTEE OF SABINE COUNTY COMMISSIONERS' COURT

OCTOBER 9, 2012

This meeting was held at noon on October 4, 2012 in the Huffman Library Board room. A quorum was present. Mrs. Robin Johnston reported that the scheduled FLW Tournament to be held in February, 2013 will not be head quartered at Fin and Feather Marina. They have not paid their Hotel/Motel tax since the first quarter of 2011. The Committee took no action, but considerable discussion ensued on the selection of a location for this event. The decision was left up to Mrs. Johnston with the caveat that adequate advertising must be forthcoming from FLW for our County marinas.

One of the four Bass Champs tournaments was held at Paradise Point Marina in early September, 2012. Commissioners' Court funded the event for \$13,250.00. Due to inexperience and a lack of support, the marina spent \$6,598.28 over the granted amount. After considerable discussion, the Committee voted unanimously to recommend to the Court that this over expenditure be funded.

In the future, such over expenditures will not be considered by the Committee with out the Commissioners' Court expressed directive. The Committee recommends that contingency amounts be clearly stated in any request for future funding.

The full intent of these costs was to put on an event that would impress the Bass Champs organization to the extent that discussion are being had about moving 3-5 tournaments to Toledo Bend next year as opposed to holding all 7 at Sam Rayburn. I believe we far surpassed all expectations.

Paradise Point Mgmt was not able to get this application together to request the funds prior to the event, and was informed that we would have to cover the cost ourselves and seek reimbursement afterwards. This event was held at Paradise Point Marina, and all attempts were made to invite all local merchants to take part in any way. It is not known at this time what the exact economical impact was on the entire county. But from the few merchants I did talk to, I expect it was outstanding. Paradise Point Mgmt. raised and is donating a total of 568.00 to the Sabine Co. Rainbow Room as a result of this. We had a turn out of over 50 volunteers to assist in hosting the event. It was a superb group effort, and I for one was very proud of this.

Paradise Point Mgmt put out over 3,000.00 itself to help cover some cost. And I also took donations and gave sponsorships, (which totaled 1200.00), to businesses to assist with some of the costs.

Paradise Point Mgmt.'s intentions were not in any way to benefit financially from this, and I didn't. But I believe the future expectations and the economical benefits for the entire county will be high as a result. I know it will have all been worth it in the years to come.

During the tournament, the amount of spectaters and fisherman that visited our county was a significant number. Upon doing a sampling. We found at times there were upwards of 300-400 people during the weigh-ins.

There was a total of 96 teams, which averaged 192 anglers, which at least half of these guys brought family or followers. We saw that at least 35% of these anglers had visited the county at least one day prior to the event for practice fishing. At least 70% were here all 3 days during the tournament. I talked to several local businesses and found that most of them, Southlake Shell, Lanes, The Sportsman, And The Sabine Lake Inn. did very well that weekend.

Everyone stated that they would like to see more tournaments come to this county. Bass Champs told me that they would definitely be back next year, and are talking about moving 3-5 of their regular season events from Rayburn to Toledo. This is exactly what we intended to accomplish by hosting the 2012 Championship.

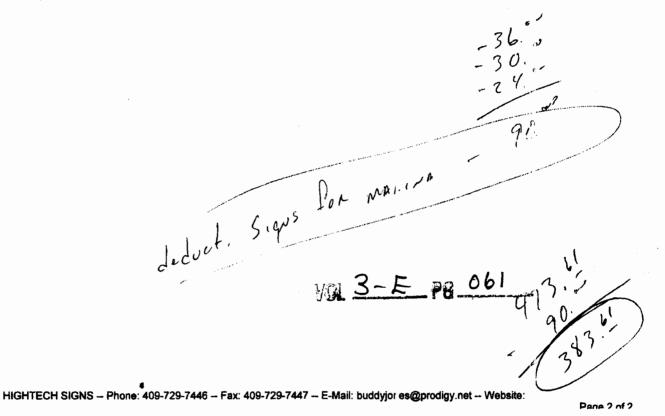

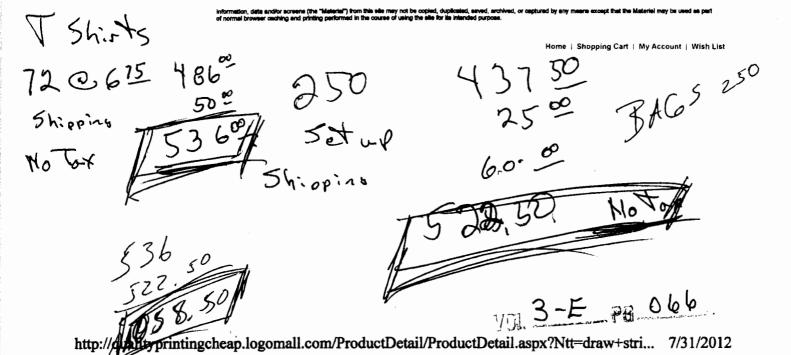
