Subject: Sabine County EMS Contract

The Sabine County Hospital Board of Directors is in receipt of your letter dated December 11, 2014, same subject as above.

After reading the article in the December 17, 2014 edition of The Sabine County Reporter, headlined: "Commissioners approve a tentative agreement with EMS", it is apparent that what the Commissioners Court approved was not what was offered nor tentatively agreed to.

The fina! offer by Sabine County EMS was to provide a 75% discount from the normal rates and only charge for 40% of the runs to Sabine County Hospital. The offer of \$60.00 per run and only charging for one of every four runs was never made by Sabine County EMS or the Hospital District.

However, the offer of only charging for 40% of the runs was made contingent upon the County's stated use of approximately 30 transports per year. Since our initial formal discussions, the County is using the ambulance much less frequently as only one transport has been required since October. The Board voted at its December 22, 2014 to withdraw the offer of billing for 40% of transports. Because of the decrease in use of the ambulance service by the Sheriff's Office, Sabine County EMS is still offering a 75% discount on transports but is withdrawing charging for only 40% of the transports as the dramatic decrease in frequency of use does not justify the deferral in billing.

Prior to drawing a contract, it is the request of the Sabine County Hospital District Board of Directors that you meet with Board President Phil Yocom, District Administrator Diane Powell, and County Attorney Bobby Neal.
