Judge Daryl Melton called the meeting to order at 8:15am.


AGENDA ITEM # 1 – Discuss with possible action on EMS Ambulance Service Interlocal Agreement with Fees for Sheriff's Office.






Commissioner Fayne Warner moved to adjourn. Commissioner Doyle Dickerson seconded the motion. All voted for and the meeting adjourned.




**INTERLOCAL AGREEMENT BETWEEN SABINE COUNTY, TEXAS and
SABINE COUNTY HOSPITAL DISTRICT, dba SABINE COUNTY EMS**

This agreement is entered into by the County of Sabine, Texas acting through its Commissioners' Court, and the Sabine County EMS, acting through its District Hospital Board.


NOW THEREFORE, THE COUNTY AND EMS agrees as follows:


- 1.0 The term of this agreement shall be effective from the date that the agreement is executed by the appropriate officials of Sabine County and Sabine County EMS and shall be in effect for one year. The Agreement may be renewed thereafter annually by the written approval of Sabine County and the Sabine County EMS.
- 2.0 The Sabine County EMS shall provide a 75% discount to Sabine County from the normal rates on transportation and services for non-insured inmates, non-indigent inmates, and inmates who are not Medicare or Medicaid recipients of the Sabine County Jail.
- 3.0 The normal rates for transportation and services are set forth on Exhibit "A" attached hereto and incorporated herein by reference.
- 4.0 Should Medicare change the guidelines set forth in Exhibit "A", the normal rates may be changed by Sabine County EMS upon sixty (60) days notice to Sabine county.


