Judge Daryl Melton called the meeting to order at 8:30am. Derek Hicks led the Court in prayer, which was followed by Commissioner Tommy Clark leading the Court in the Pledge of Allegiance.

**AGENDA ITEM # 1 – General Business.**

Commissioner Tommy Clark moved to approve one set of minutes as written. Commissioner Fayne Warner seconded the motion. All voted for and the motion carried.

**AGENDA ITEM # 2 - Discuss with necessary action on Line Item Transfers.**

**AGENDA ITEM # 3 – Consider and take action on any necessary Budget Amendment(s).**

**AGENDA ITEM # 4 – Discuss with possible action regarding Unclaimed Capital Credits received by Comptroller.**

Commissioner Doyle Dickerson moved to approve giving Judge Melton the authority to apply for the Unclaimed Capital Credits from the Comptroller. Commissioner Tommy Clark seconded the motion all voted for and the motion carried.

**AGENDA ITEM # 5 – Discuss with possible action on funding request(s) from Hotel/Motel tax funds with recommendations from Tourism Committee.**

Maurice Patterson addressed the Court with recommendations from the Tourism Committee for funding from the Hotel/Motel tax funds as follows:

The Tourism Committee recommends \$7,500 for Texas State Bass Tournament that is scheduled to be held in 2 weeks at the Fin and Feather Marina.

Commissioner Doyle Dickerson moved to approve the request. Commissioner Jimmy McDaniel seconded the motion. All voted for and the motion carried.

Belinda Gay addressed the Court on behalf of the Patricia Huffman Smith Museum or the "NASA Columbia Museum" and requested \$5,000.00 for brochures and advertising material to place at tourism centers.

The Tourism Committee recommends \$5,000 for the Advance Rack Brochures.

Commissioner Jimmy McDaniel moved to approve the \$5,000. Commissioner Doyle Dickerson seconded the motion. All voted for and the motion carried.
