Upon a request from Ms. Melissa McGee, I am providing my recollection of the circumstances surrounding the above subject road. The question as to whether or not Wright Lane was at one time a County Road, I will try and demonstrate my belief that in fact it was a County maintained road.

I served as Sabine Commissioner of Pct.#4 from January 01, 1999 until December 31, 2002. The road in question lay within Pct.4. A retired Commissioner went with me on my due diligence tour of all the maintained roads, it was brought to my attention that Wright Lane southeastward from Parrish-Barrett Circle to a point past the last residence was maintained. The old wooden bridge across what I recall as being Mattox Creek had been long since washed out and the road had been allowed to grow up with underbrush. From the East side traveling from FM 2784 Westward toward Mattox Creek was maintained on a minimal basis to a spot know as Anderson Cemetery. There was no one living along this section of Wright Lane, so the maintenance was only for access to property and the Cemetery. Since County funds were very scarce, resources were used to maintain roads that people lived on. No effort was ever made on my part to reopen the referenced road even though I did believe it to be a County Road.

There is evidence along the part that is now grown up with underbrush that there was indeed a road there because some of the old bridge timbers could be seen according to Mr. Felix Holmes. Also according to Mr. Holmes the old ditch lines are visible. You can clearly see some of the above by looking at Google earth maps.

Unless there is evidence that the Court has taken specific action to abandon the part that is grown up, then It is my belief Wright Lane is continuous from FN 2784 to Parrish-Barrett Circle, even thought it is not passable.

I was employed by Sabine County, Texas beginning in November 1994 for Precinct #4, Sabine County, Texas. One of the roads that I helped maintain was Wright Lane that ran west from FM 2784 to Parrish Barrett Circle. Although the bridge was washed out in between FM 2784 and Parrish Barrett Circle, I helped maintain the road from FM 2784 to the cemetery located about 1 mile west of FM 2784. I specifically remember working on the road when Ralph Dalton who worked for Leon Adickes at the pharmacy owned 50 acres of property on the road. Mr. Dalton had electricity ran from the Parish Barrett Circle along Wright Lane to his property when he purchased it. I graded the road and spread four to five loads of gravel from the gravel pit located at FM 2784 and Wright Lane that was operated by Sabine County Commissioner, Precinct #4, Chester Cox.

I also remember around 1997 when Mark Birdwell was surveying property off of the County Road and the road was being repaired due to damage by a logging company when Dr. Arnold had his timber cut.
