

**FIRST JUDICIAL DISTRICT
CLEAR AGREEMENT**

This agreement memorializes the terms of use of the Coalition of Law Enforcement And Retail (CLEAR) access which is to be purchased by the First Judicial District Attorney's Office (DA):

The DA will contract with West Publishing (West) for access to CLEAR resources. That contract will be for a 3 year term. This allows the DA to get a 20% discount. This contract will allow for 5 separate user names and passwords to have access to the CLEAR resources.

Pursuant to the terms of this agreement the DA will designate "approved employees" from each of the following agencies, which will have access to the CLEAR resources: 1. Sabine County Sheriff's Office; 2. San Augustine County Sheriff's Office; 3. Hemphill Police Department; and 4. San Augustine Police Department. Each "approved employee" will have a username and password for access to the CLEAR resources.

Each "approved employee" will be responsible for knowing the terms of use of the CLEAR resources. A copy of the contract between the DA and West will be provided to each "approved employee" and they will be asked to sign a copy signifying that they have read and understood the contract.

The cost of the CLEAR access will be \$2,544 for year one, \$2,671.20 for year two, and \$2,804.76 for year three. The amounts will be divided amongst the above listed agencies as follows: 1. 20% DA; 2. 20% SCSO; 3. 20% SASO; 4. 20% HPD; 5. 20% SAPD.

The agencies will bring their annual payment to the DA's office upon the signing of the contract with West. DA will give receipts and provide documentation reflecting payments to West.

Each agency will make the next year's payment on or before the anniversary date of the Contract with West.

The annual payments will be as follows:

Year 1 - \$508.80

Year 2 - \$534.24

Year 3 - \$560.95

Each agency will pay this amount respectively.
