He gave a brief explanation of why Shelby County is wanting to merge with the 1st Judicial Community Supervision & Corrections Department. The cost of the merger for Sabine County will stay the same at \$490.

Judge Daryl Melton state he doesn't see a problem with the merger.

Commissioner Charles Ellison moved to accept Shelby County into the 1st Judicial Community Supervision & Corrections. Commissioner Jimmy McDaniel Seconded. All vote for and motion carried.

AGENDA ITEM #7 – Discuss with possible action on approval for National Day of Prayer Program on Lawn on May 3.

Judge Daryl Melton received a call from Ms. Broadway requesting to use the courthouse lawn to have the National Day of Prayer Program this year.

Commissioner Jimmy McDaniel moved approve the use of the courthouse lawn for this program. Commissioner Charles Ellison seconded. All voted for and motion carried.

<u>AGENDA Item #8</u> – Discuss with possible action on Proposals for Roof Repairs on Administration Building.

One bid was received from Chance Construction for \$2,224.

<u>AGENDA ITEM #9</u> – Discuss with possible action on Proposals for Gutter repairs on Courthouse.

One bid was received from Chance Construction for \$3,101.60.

Judge Daryl Melton stated that he would rather replace all gutters not just ones that are leaking.

Commissioner Fayne Warner proceed with repairs and have the rest of the gutters inspected. Commissioner Tommy Clark seconded. Commissioner Jimmy McDaniel abstained from voting. Commissioners Clark, Ellison and Warner voted for and motion carried. See attached copies of bids.

AGENDA ITEM #10 – Discuss with possible action on Veteran's Officer requiring additional funds for continuing education.

Veteran's Officer Thomas Warren that his fall Conference has been canceled. Training will be done on-line instead. The cost will be \$449 annually and he will also have to have a signature pad.

Judge Daryl Melton said right now his budget is at 17% so it's doing ok right now. We may have to look at it later this year. No action taken.

<u>AGENDA ITEM #11</u> – Discuss with possible action on ranking for Specialized Drug Investigator from Justice Assistant Grant by DETCOG Criminal Justice Division.

Judge Daryl Melton informed the court that we have already voted to apply for a grant in the amount of \$35,000. Tom Maddox, Sheriff, is ranked #2 out of 8 applicant and each one will receive something. The total amount of the Grant funding is around \$170,000. This Officer heads up our whole narcotics program.

Commissioner Charles Ellison moved to accept the \$35,000 Grant from DETCOG. Commissioner Fayne Warner seconded. All voted for and motion carried.

AGENDA ITEM #12 – Discuss with possible action on Administrative Services with David Waxman, Inc. for GLO Contract #18-202-000-A-779 Hurricane Ike 2.3 aka Davidson Road Bridge Project.

Judge Daryl Melton said the county will be receiving the funds and we will pay David Waxman so we have to have a contract with him. This project should start around August. Judge Melton ask the court to give him approval to sign off on the contract if Robert Neal, County Attorney, agrees that there is no problem with the contract and we can proceed with this project.

Commissioner Charles Ellison moved to accept this administration contract with David Waxman and allow the County Judge to sign after approval from Robert Neal, County Attorney. Commissioner Fayne Warner seconded. All voted for and motion carried.

AGENDA ITEM # 11 - Discuss with possible action on paying Accounts and Salaries.

Commissioner Fayne Warner moved to pay Accounts and Salaries as submitted. Commissioner Charles Ellison seconded the motion. All voted for and the motion carried.
