Judge Melton called the meeting to order at 8:30 a.m. and led the Court in prayer. Commissioner Clark led the Pledge of Allegiance.

AGENDA ITEM #1-General Business

Commissioner McDaniel moved to approve 2 sets of minutes as written. Commissioner Warner seconded. All voted for. Motion carried.

AGENDA ITEM #2-Discuss with possible action on Line Item Transfers

No line item transfers were submitted.

AGENDA ITEM #3-Discuss with possible action on any necessary budget amendments

AGENDA ITEM #4-Discuss with possible action on renewal of Economic Director, Charlie Dromgoole's contract

Commissioner Ellison moved to table the above agenda item. Commissioner Warner seconded. All voted for. Motion carried.

AGENDA ITEM #6-Discuss with possible action on consideration for reduction of speed for Woodland Estates Subdivision, Pct. 2

Judge Melton stated that the Court has completed the required posting, advertising in the local paper twice and held a public hearing. No opposition was brought to the Court concerning reducing the speed limit to 20 mph on the subdivision roads. He stated that this does not include FM 3449 which runs through the subdivision.

Commissioner McDaniel moved to approve setting a speed limit of 20 mph on the roads within Woodland Estates Subdivision except for FM 3449. Commissioner Ellison seconded. All voted for. Motion carried.

AGENDA ITEM #7-Discuss with possible action on paying accounts and salaries

Commissioner McDaniel moved to pay the accounts and salaries. Commissioner Ellison seconded. All voted for. Motion carried.

AGENDA ITEM #8-Public Comments

Judge Melton gave the Court a brief update on a possible grant that will only be for counties that were affected by Hurricane Harvey.
