
INTERLOCAL AGREEMENT BETWEEN SABINE COUNTY CLERK, SABINE COUNTY, TEXAS and CITY OF HEMPHILL, TEXAS


This agreement is entered into by the County Clerk of Sabine, Texas acting through its Commissioners' Court, and the City of Hemphill, Texas, acting through its City Counsel.

NOW THEREFORE, THE CLERK AND CITY agrees as follows:


- 1.0 The term of this agreement shall be effective from the date that the agreement is executed by the appropriate officials of Sabine County and City of Hemphill, Texas and shall be in effect for one year. The Agreement may be renewed thereafter annually by the written approval of Sabine County Clerk and the Mayor of the City of Hemphill, Texas.
- 2.0 The City of Hemphill, Texas shall have access to the County Clerk's Early Voting location during the period of the City's early voting election which is April 23, 2018 thru April 27, 2018 between the times of 8:00 a.m. until 4:00 p.m. and April 30, 2018 thru May 1, 2018 between the times of 7:00 a.m. until 7:00 p.m. and during the period of the City's election day which is May 5, 2018 between the times of 7:00 a.m. until 7:00 p.m.
- 3.0 There shall not be a yearly fee for using the Clerk's early voting location. The City will be responsible for any damages or incidents directly related to the City's use of the Clerk's early voting room.
- 4.0 The City of Hemphill shall pay a Clerk employee up to three hours for opening and closing the early voting room on Election Day, and up to five hours for the extended early voting week.

INTERLOCAL AGREEMENT BETWEEN SABINE COUNTY CLERK, SABINE COUNTY, TEXAS and HEMPHILL INDEPENDENT SCHOOL DISTRICT, HEMPHILL, TEXAS

This agreement is entered into by the County Clerk of Sabine, Texas acting through its Commissioners' Court, and the Hemphill Independent School District, Hemphill, Texas, acting through its Superintendent.

NOW THEREFORE, THE CLERK AND SCHOOL agrees as follows:

- 1.0 The term of this agreement shall be effective from the date that the agreement is executed by the Judge of Sabine County and the Superintendent of Hemphill ISD and shall be in effect for one year. The Agreement may be renewed thereafter annually by the written approval of the Sabine County Clerk and the Superintendent of the Hemphill ISD.
- 2.0 Hemphill ISD shall have access to the Clerk's Early Voting location during the period of the School's early voting election which is April 23, 2018 thru April 27, 2018 between the times of 8:00 a.m. until 4:00 p.m. and April 30, 2018 thru May 1, 2018 between the times of 7:00 a.m. until 7:00 p.m. and during the period of the School's election day which is May 5, 2018 between the times of 7:00 a.m. until 7:00 p.m.
- 3.0 There shall not be a yearly fee for using the Clerk's early voting location. Hemphill ISD will be responsible for any damages or incidents directly related to Hemphill ISD's use of the Clerk's early voting room.
- 4.0 Hemphill ISD shall pay a Clerk employee up to three hours for opening and closing the early voting room on Election Day, and up to five hours for the extended early voting week.
