He plans to do the best he can for everyone in his precinct, looking at bus routes and mail routes first. Ms. Reddell made the request that no more rock be put on the roads in Beechwood I. Judge Melton said they had a 5-year plan and were looking into additional funding options, and that Commissioners were currently working from carryover. Ms. Reddell informed the Court that she had a lot at stake, with 3 VRBO rentals in Beechwood I alone. She then asked the Court if they were aware that according to the Association of Counties, the budget monies do not have to be split equally between precincts. She believes there is justification for spending more money in Beechwood I, because it brings in a lot of tax dollars. Commissioner McDaniel responded by saying he didn't play favorites, and that was the only fair way he knew to do it. And that he will do what he can, when he can, to her road. Ms. Reddell concluded by saying this was not going away, she was not going away. Judge Melton offered to speak with Ms. Reddell after Court adjourned, and she agreed.
