That the above resolutions will stand for any and all former appraisal rolls and/or certified tax rolls of the Sabine County Tax Office and the Sabine County Commissioners Court.



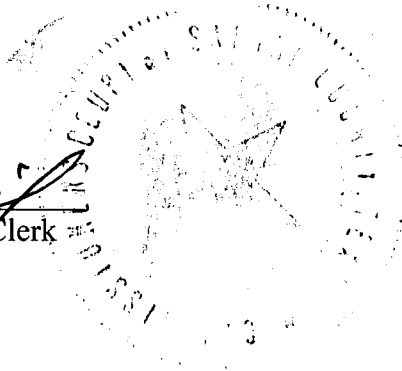

**A RESOLUTION LEVYING A TAX RATE FOR  
SABINE COUNTY  
FOR THE TAX YEAR OF 2020**

**BE IT ORDAINED AND ORDERED** by the Sabine County Commissioners Court that:

**WE**, the Commissioners Court of Sabine County, hereby levy or adopt the tax rate on \$100.00 valuation for this county for the 2020tax year as follows:

\$ .3999999 /\$100 for the purpose of maintenance and operations

\$ /\$100 for the payment of principal and interest on bonds

\$ .3999999 /\$100 **TOTAL TAX RATE**

**THIS TAX RATE WILL GENERATE ABOUT THE SAME AS LAST YEAR'S TAX RATE FOR MAINTENANCE AND OPERATIONS.**

The tax assessor/collector is hereby authorized to assess and collect the taxes of Sabine County employing the above rate.

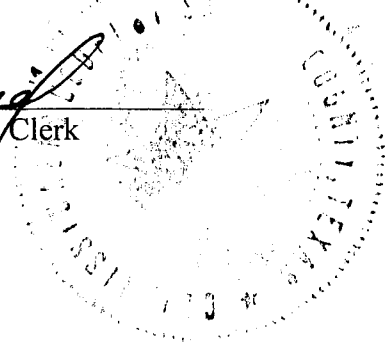
