Judge Melton said everyone has really stepped up to help keep our county going. Ronald Barlow mentioned that we were fortunate to have little livestock/timber loss in the county; and that those losses can be reported thru USDA, not FEMA. He also mentioned the County Livestock Show will be March 26-27th. Judge Melton updated on Covid. Cases are down. Should be getting 400 doses of vaccines this week. Jasper and Lufkin are HUBS, and are getting 1600 vaccines. So if you are able to travel, he recommends going to one of those HUB locations.
