

Monday, March 8, 2021 the Sabine County Commissioners' Court met in regular session. The following members of Court were present:

Judge Melton called the meeting to order at 8:30 a.m. Commissioner McDaniel led the Court in prayer. Commissioner Cox led the Court in the Pledge of Allegiance.

AGENDA ITEM #1-General Business

Commissioner McDaniel moved to approve one set of minutes, as written, for the February 22nd regular meeting. Commissioner Lowe seconded. All in favor. Motion carried.

AGENDA ITEM #2-Discuss with possible action on Line Item Transfers

No line item transfers were submitted.

AGENDA ITEM #3-Discuss with possible action on any necessary Budget Amendments

No budget amendments were submitted.

AGENDA ITEM #4-Discuss with possible action on Resolution for Law Enforcement at Mill Creek Park, Lake Sam Rayburn

George Griffin presented the contract to the Court and explained this is an annual contract that the County is completely reimbursed for. This keeps an officer at Mill Creek Park on weekends from May thru September. (A total of 43 days) Commissioner Lowe moved to approve the Resolution for Law Enforcement at Mill Creek Park, Lake Sam Rayburn. Commissioner Jacks seconded. All in favor. Motion Carries.

[AGENDA ITEM #5](#)-Discuss with possible action on allowing Pct. 3 to sell salvage culvert according to LGC sec 263.152 (c) such as relieving the county of transportation or disposal expenses related to the property

Commissioner Jacks told the Court he had some inquiries about a railcar bridge that had been removed a couple years ago; as it was deemed unsafe. It's just sitting on the side of the road and he needs to get it moved. He'd like to sell it if he can get a decent offer. Judge Melton commented that the cost of moving it would be more than it's worth. Commissioner McDaniel moved to allow Commissioner Jacks to sell the salvage railcar for whatever he can get for it. Commissioner Lowe seconded. All in favor. Motion Carries.

AGENDA ITEM #6- Discuss with possible action on Racial Profiling Report by Sheriff's Office

George Griffin presented to the Court the yearly Racial Profiling Report that the Sheriff's Office submits to the State, of all the traffic stops with racial breakdown. Judge Melton stated that there is no vote necessary. [See Attached.](#)

AGENDA ITEM #7 – Discuss with possible action on the approval for donation of equipment for Pct. 2 Constable

He does ask the Court to allow an anonymous person to make a donation to the County for the purchase of needed equipment for Constable 2. Commissioner Cox moves to approve the anonymous donation. Commissioner Lowe seconds. All in favor. Motion carries.

AGENDA ITEM #8 – Discuss with possible action on Interlocal Agreement between Sabine County Clerk, Sabine County and the City of Hemphill, regarding early voting and election day location

Angie Garza, Elections Deputy; explained this is an agreement to allow the City of Hemphill to use our Election Room for their election. Commissioner Lowe moves to approve Interlocal Agreement. Commissioner Jacks seconds. All in favor. Motion carries. [See Attached.](#)
