



CSCD OVERVIEW

The First Judicial District Community Supervision and Corrections Department (CSCD) was formed in March 1973, for the purpose of providing adult and juvenile probation services for the First Judicial District of Texas. It was composed of **Jasper**, Newton, Sabine and San Augustine Counties. In June of 1989, the Department was restructured. The adult and juvenile functions of the Department were split into two separate Departments.

After being operated under the Harrison County CSCD until 1978, Panola and Shelby County split and became the 123rd Judicial District CSCD. Some thirty-eight years later, the Department split once again in December of 2016 and became their on CSCDs. Almost two years later on September 1, 2018, the Shelby County CSCD merged with the First Judicial District CSCD. The Department has now become known as the East Texas CSCD.

The CSCD is composed of **Jasper**, Newton, Sabine, San Augustine and Shelby Counties. These counties cover approximately 3917 square miles in the Deep East Texas region. According to the 2020 census, the Department serves approximately 87,031 citizens. The Department serves the 1st, 1-A, 123rd and 273rd Judicial District Courts as well as the County Courts for each of the five counties.

The Department serves adult offenders placed on community supervision, pre-trial diversion and bond supervision. The Department is also tasked with the duty of disbursing court ordered fees such as court cost, fine and victim restitution. Being funded through state funds, grants and offender fees, the CSCD provides high quality and fiscally effective services to offenders.

The strategic plan will provide information for the goals, strategies and objectives of the Department for the next four years. The plan will also provide a view of the Department's jurisdictional population and offender profiles. The three top offenses committed by offenders in our jurisdiction are Possession of a Controlled Substance 31.00%, Theft 27.3% and violent crimes at 18.3%. Due to substance abuse playing a major role in these offenses, it will be necessary for the Department to provide substance abuse counseling services.

The availability of substance abuse counseling services within the Department's jurisdiction are limited, and the services that are available have limits on the number of individuals who can be served. The cost of the services can also be prohibitive for offenders (according to U.S. Census Bureau, 20.48% of residents within the Department's jurisdiction are below the poverty line. The income per capita in the jurisdiction is \$20,003.00, which includes all adults and children) creating the need for the Department to provide substance abuse counseling. Due to this information, the Department began to pay for substance abuse evaluations, outpatient substance abuse treatment, as well as sex offender treatment in fiscal year 2015 after a 17 year hiatus. Shelby County CSCD lost a drug court grant when Panola split the two offices creating a burden on Shelby CSCD being able to effectively supervise defendants with substance abuse issues.


There has been an increase in supervision placements of offenders with mental health impairments as well as offenders who are placed due to sex offenses. The Department has been completing the mental health trailer from the Texas Risk Assessment System (TRAS) on all offenders to determine the usefulness of a mental health caseload officer who would cover the entire district.

To address a rise in high risk/sex offender placements, the Department applied for and received a Diversionary Program (DP) Grant for fiscal years 2016, 2017, 2018, 2019, 2020 and 2021. The awarding of this DP grant has been of historic proportion, as this Department had never applied for this money. This money has also allowed for the Department to absorb the sex offender population from Shelby County and pay for their treatment.

In fiscal year 2019 the Department was granted one-time de-obligated money to expand service for an intensive outpatient substance abuse program. This program boosted our success rate on our chemical dependency caseload to 68%. Based on the success of the program, the Department applied for and received DP Grant funding for an Intensive Outpatient Program which covers the entire jurisdiction for fiscal years 2020 and 2021. Because of this influx in funding, the Department will have the flexibility to add other services which will benefit offenders as well as the Department.

Program Descriptions

- <u>High Risk Caseload</u> provides specialized supervision to those individuals designated by the CSCD to have higher risk or need than other individuals; such as substance abuse, violent offenders, offenders with a history of non-compliance, mental health needs, or a combination.
- <u>Pre-trial Diversion Program</u> provides specialized supervision to those individuals placed on pre-trial diversion by the Court and/or the County or District Attorney's Offices within the East Texas CSCD which provides services to offenders charged with a criminal offense who have not been placed on either adjudicated or deferred adjudication probation in the instant offense; supervision may not exceed 2 years.
- <u>Chemical Dependency Caseload</u> provides specialized supervision to those individuals designated by the CSCD to have a higher risk or need than other individuals specific to drugs, alcohol or a combination thereof.
- <u>Life Skills</u> provides alcohol and drug awareness, driving while license invalid, marijuana awareness, readiness to change, theft intervention and violence intervention which provides services to individuals that have shown a need for help in improving these areas of their life and become a more productive citizen within the community. This program contains cognitive aspects that address offender's criminal thinking errors as well.
- <u>Substance Abuse Services</u> provides intensive outpatient substance abuse treatment locally to those individuals placed on felony supervision or felony pretrial supervision for a period of 90 days.
- <u>Community Corrections Supervision Services</u> provides funds which are used to pay CSO's salary who supervise a regular caseload, not specialized caseloads.

- <u>Community Service Restitution</u> a Community Corrections program that oversees and/or coordinates work assignments for offenders required to perform community service restitution as a condition of community supervision

Perspectives on Programs

In Fiscal Year 2016, the East Texas CSCD was granted the first diversionary program grant in the history of the department to provide services for the sex offender and high-risk caseload by the Texas Department of Criminal Justice – Community Justice Assistance Division. Due to receiving this grant, services such as specialized supervision, counseling, and treatment were provided at no cost to the offender. Typically, these programs and services are funded and monitored by the State are available only to those offenders who qualify for services based on grant conditions set by the State.

Beginning Fiscal Year 2020, the East Texas CSCD was granted two additional diversionary program grants to include one for pre-trial diversion supervision and substance abuse services. The substance abuse services program is incorporated into an intensive outpatient program in Jasper as well as in Center for their drug court docket.

Certain programs and services are operated directly by TDCJ or by local CSCDs. Some of the State operated programs which are offered to offenders include, but not limited to: Residential Substance Abuse Treatment, Community Corrections Facilities, Intermediate Sanction Facilities, and Substance Abuse Felony Punishment Facility.

Other programs and services for offenders which are used by the East Texas CSCD are offered by non-profit organizations. These private entities obtain grants and funding to provide services to offenders at little or no cost to the Offender. Some of the privately-operated programs which are offered to offenders include, but not limited to: Residential Substance Abuse Treatment, Outpatient Substance Abuse Treatment, Residential Half-way Housing, and Residential Mental Health Services.

The East Texas CSCD also utilizes offender paid programs and services which means some services provided to offenders are required to be paid for by the offender; either directly to the facilitator of the program or reimbursed to the CSCD. Some of the programs offered to offenders include Drug Testing, Ignition Interlock Device, Anger Management, Parenting Classes, Batters' Intervention and Prevention Program, Family Counseling, Cognitive Awareness, DWI Education, Drug Offender Education, and Mental Health Services.


On occasions when the court orders it, the department utilizes Pre-Sentence Investigations as sentencing tools for the Court. These investigations utilize criminal, social, victim, military, and economic information about the offender to determine initial supervision needs. These needs are further defined by the utilization of the Texas Risk Assessment System.

Beginning in Fiscal Year 2020, TCOOMI has expanded its rural mental health initiative to include Jasper and Newton counties. The East Texas CSCD has partnered with the Local Mental Health Authority to provide "in-house" mental health services. This program is labeled as TCOOMI and provides specialized supervision and skills training to offenders that qualify, at no cost to them.

Providing enough program options to meet the needs of the offender population helps ensure offenders are provided the opportunity to learn and change their criminal behaviors. Offenders are placed in appropriate level of services based upon their assessed risk and needs as determined by the TRAS, an evidence-based assessment tool. Officers work with the offenders to motivate and encourage them to be successful on probation. Enrollment and Completion of these programs is monitored by the CSCD and reported accordingly.



Program Success Rates

Perspectives on Program Success Rates

Using program data submitted to the Community Supervision Tracking System-Intermediate System (CSTS-ISYS), TDCJ-CJAD calculates program success rates for each fiscal year. These rates are made available to each CSCD. Statewide rates are calculated for each program type so CSCDs can compare their program to all programs of the same type in the state. Success rates are calculated using the following formula: Completions / (Completions + Revocations + Absconded + Violations).

During Fiscal Year 2019, substance abuse services success rates more than double from fiscal year previous fiscal year from 25% to 60.66%. Although our success rate is still under the state rate, we feel this is a significant advance in our program. The East Texas CSCD believes there were several contributing factors working together to bolster these rates. First, the department


had applied for and received \$20,000.00 in one-time de-obligated money from CJAD and placed this money into the program. With this additional money, the department was able to contract with a provider with an excellent program. These two factors as well as the improved provider and the department have played a significant role in the success of the program

During Fiscal Year 2019, the chemical dependency caseload success rate almost doubled from 34.88% to 64%. With the introduction of the improved substance abuse services program and a more rehab-oriented philosophy within the department played a huge part in the increase in success in the program. Again, even though the department did not meet the state wide benchmark, there were significant advances.

As you will see in the graph above, the sex offender program is three percentage points above the state benchmark. This is also an increase of over twenty percentage points from the previous fiscal year. The East Texas CSCD believes the increased success rates are directly attributed to receiving the diversionary grant in 2016. There was a lull in success rates due to starting the program. Now that clients have been in the program for a significant period of time, they are discharging from counseling successfully.

Perspectives on Offender Population

The overall population and community supervision placements have declined within the jurisdiction of the East Texas CSCD, since 2017. The felony direct population and community supervision placements are variables to calculate the amount of BS & CC funds allocated to CSCDs, and declining population results in less funding for essential operating costs. What are the causes of declining population?

- Reduced crime rates .
- Changes in the overall judicial system and community corrections field
- Economic decline makes offenders more likely to choose incarceration over probation .



Perspectives on Revocation Rates

For 2021, the East Texas CSCD maintained a felony revocation rate which was below the state average. The misdemeanor revocation rate was also lower than the state average. The revocation rates can be attributed to a variety of factors:

- An evidence-based assessment process
- Specialized supervision and treatment based upon assessments
- Use of progressive sanctions
- Prosecutorial discretion
- Judicial discretion


For FY2021, it being that the revocation rates for were 5.41% and 5.90%, for felony and misdemeanor offenders respectively. This means the *completion rate* for the department was **94.59%** and **94.10%**, respectively.

Technical Revocations

FY2021



Technical violations and revocations are defined as any violation other than a new offense. During fiscal year 2021, the East Texas CSCD maintained a technical revocation rate within the misdemeanor and felony populations less than the state rate. Technical revocations include, but are not limited to failure to report, failed multiple drug screens, failure to attend or successfully complete counseling or treatment programs. The Department's lower rate could be due to the philosophy of frequently offering sanctions in lieu of revocation proceedings for technical violations.

Absconding is considered a technical violation in the state of Texas unlike the federal level. Absconding is one of the most common violations among offenders who do not comply with the terms and conditions of their supervision. Absconding can be one of the most difficult violations to address due to the inability to confront the offender. In many cases, a significant period of time passes before the offender is arrested by law enforcement. If enough time passes and the offender's period of supervision has expired, state law only allows for the reinstatement of supervision within a one (1) year of anniversary of the expiration of supervision. If the disposition of the case is settled after this period of time, the only available relief to the offender is to serve their time incarceration time or for the case to be dismissed.

CSCD Goal – Staff Retention and Competitive Hires

The goal of the East Texas CSCD will be to improve staff retention as well as increase beginning salary to a more competitive compensation for the local area.

Our Department has experienced a significant decrease in staff retention over the past few years. The turnover rate for the department over the past two fiscal years has been twenty-five percent. If you look at the past four years, the turnover rate increases to fifty percent.

With a constant turnover, there is a decrease in experience within the department as well as an increased expense of training new officers. The primary reason for staff resignations indicated low wages compared to other agencies where they seek employment.

Upon completion of a recent wage survey of local correctional professionals and teachers, the CSCD's beginning salaries are extremely inferior and range from \$9,000 to \$12,000 annually below our competitors. Low salaries directly impact the affective hiring of skilled staff and in many cases even qualified staff.

CSCD Objectives and Strategies

The East Texas CSCD will utilize funding provided by State Aid to compensate staff salaries to the level of professional demand in order to retain qualified staff.

- Compile salary information for positions in direct competition for qualified CSCD positions by June 2022.
- Develop/Adjust career ladders and advancement procedures for CSCD positions July 2022
- Develop/Adjust salary schedule for CSCD positions based on compared information from related professional competitors and/or other CSCDs – July 2022
