**AGENDA ITEM #1**-Discuss with possible action on Agreement/Contract with C. Paul Phelps Correctional Center, DeQuincy, Louisiana for housing inmates for Sheriff Department


AGENDA ITEM #2-Discuss with possible action on expenditure for county radio system

Sheriff Maddox and David Roach (Office of Emergency Management) explained that the county radio system is in need of repair and informed the court of the issues it causes. AGENDA ITEM #3-Discuss with possible action on voice over recorder for Sheriff Department

Sheriff Maddox presented a quote from Vistacom for a new voice over recorder system. He stated that the present system is antiquated and does not work properly in securing communications/transmissions into the sheriff's office. DETCOG has the funds available to assist with the purchase. Commissioner Jacks moved to go forward with Vistacom for the voice over recorder system for the Sheriff Department.
