Sabine County Economic Development Progress Report January, February, March 2024 Prepared by Charlie Dromgoole

- I attended the SCEDAC meeting on January 23 in Hemphill.
- Sabine County has received the draft of the economic development strategic plan that was made possible through a grant from the Texas Department of Agriculture's new pilot program entitled Rural Economic Development (RED) Grant Pilot. After completing the plan, we will be able to apply for a grant of up to \$1,000,000 to complete one of the projects identified in the plan. Sabine County has chosen the project to be the construction of Amphitheatre in conjunction with Sabine River Authority at the Sabinetown Park that is currently under construction.
- We have applied for three (3) more paddling trails through the Texas Parks & Wildlife. These
 will be located on Toledo Bend at the MidLake Campground, Sandals & Spurs Lakefront Resort,
 and Lost Frontier R.V. Park & Marina. Applications were submitted and received on March 4,
 2024. We are now awaiting the completion of the selection process by Texas Parks & Wildlife.
- The tourism website has been reconstructed to make it more mobile phone and user friendly. Pennie Ferguson has made numerous updates that needed to be made. Pennie now has access to the website to make corrections and additions in a timelier manner and has done a great job in updating the information. Please visit the website at https://visitsabinecounty.com/.
- Last year, the Sabine County Tourism Committee contracted billboards in 6 locations in the vicinity of Beaumont, Livingston, Jasper, Silsbee, Carthage and I-20. Debra Lane LeBlanc has contacted the two billboard companies that we used to get updated availability. After reviewing potential sites, we have decided to wait until closer to the completion of Sabinetown Park so that we can spend our limited funds to promote the opening of the park.
- Since we have updated the hotel feasibility study with Source Strategies, we have been sending the updated information to previous contacts that were made earlier for potential hotel developers to let them know about the new development at Sabinetown Park.
- We have renewed our contract with Go-Texas Travel Sites, an online tourism marketing firm that markets Sabine County. We received 1,870 requests for information in 2023. Since inception in December 2019, we have received 6,151 requests for information. All inquiries receive an email promoting Sabine County along with a link to our website and the Sabine County Magazine. We maintain a complete database for future marketing.
- We hosted the Texas representative of BNSF railroad responsible for Sabine County on October 24 for a tour of the rail accessible properties in Sabine County and throughout the area. This was conducted in conjunction with the Texas Forest Country Partnership.
- We submitted an RFI to the Governor's Office of Economic Development on November 1, 2023 for Project Cabana 3. This is a project that is looking to build a complex of hydroponic greenhouses for growing vegetables large grocery chains and prefers to locate in rural areas. They will be developing greenhouses in several states and should begin looking at Texas sites in 2024. The consultant is impressed with our site and its capabilities.
