Re: City of Pineland Airport Runway Reconstruction Funding

Dear Judge Melton and Sabine County Commissioners,

The City of Pineland has been awarded a grant from TxDot Aviation for a pavement rehabilitation construction project in the amount of \$2,697,014.00. The City match of this grant is ten (10) percent for a total of \$269,701.40.

As you are fully aware, the airport serves the entire county and not just the citizens of the City of Pineland, therefore, the City is requesting the county help with the monetary match for this project. The airport currently has six hangers on site and each of those are owned by citizens who are residents of Sabine County but not citizens of the City of Pineland.

The airport serves a vital interest not only for the citizens of Pineland but also the citizens of Sabine county. During medical emergencies, it serves as a landing zone for Medi-vac aircraft, serves as a landing zone for fire fighters during events such as wildfires and extreme emergencies, utilized by Texas Forest Service when spraying herbicides on the various tracks of timber, and serves as a landing zone for various individuals who visit the county for business and recreational purposes.

The City of Pineland is respectfully requesting the County to assist the city in the amount of \$75,000 to assist with this project. As each of you are aware, the costs of materials are constantly rising, and we need to act on this project as quickly as possible to help save our citizens from rising construction costs. Included in this letter is the Probable Construction Costs Summary as of February 11, 2025. If you have any additional questions, please do not hesitate to reach out to the City.
