

## CONTRACT (GLO)

THIS AGREEMENT MADE THIS 14<sup>th</sup> day of April, 2025, by and between Rayford's Truck & Tractor a corporation organized and existing under the laws of the State of Texas, hereinafter called the "Contractor", and the Sabine County, hereinafter called the "Local Public Agency".

WITNESSETH, that the Contractor and the Local Public Agency for the considerations stated herein mutually agree as follows:

### ARTICLE 1. STATEMENT OF WORK

The Contractor shall furnish all supervision, technical personnel, labor, materials, machinery, tools, equipment and services, including utility and transportation services, and perform and complete all work required for the construction of the Improvements embraced in the Project; namely, Sabine County GLO CDBG Regional Mitigation Program Projects Hurricane Harvey State MID GLO Project No. 24-065-034-E489 and required supplemental work for the Sabine County GLO CDBG Regional Mitigation Program Projects Hurricane Harvey State MID GLO Project No. 24-065-034-E489 all in strict accordance with the Contract Documents including all addenda thereto, numbered N/A, dated N/A, all as prepared by GLS, acting and in these Contract documents preparation, referred to as the "Engineer".

### ARTICLE 2. THE CONTRACT PRICE

The Local Public Agency will pay the Contractor for the performance of the Contract in current funds, for the total quantities of work performed at the unit prices stipulated in the Bid for the several respective items of work completed subject to additions and deductions as approved by the GLO (Grantor Agency) and the Local Public Agency, and as provided in Section 109 hereof.
