# Sabine County Economic Development Progress Report April, May, and June 2025 Prepared by Charlie Dromgoole

- We have completed submitting all the information for three (3) more paddling trails through the Texas Parks & Wildlife. These will be located on Toledo Bend at Mid Lake, Palo Gaucho Bayou, and Lost Frontier. The official launch for these 3 trails will be on Thursday, July 17 at 6:00 p.m. at the Lost Frontier boat launch. Representatives from Texas Parks and Wildlife and Coastal Fisheries will be on hand for the event. The website for the paddling trails and a press release announcing the trails will be available at that time. The event is being held in July since it is National Lake Appreciation month. We already have the sign frames and the inserts on hand for the information kiosk. We have submitted the application for an additional paddling trail at the Six Mile North boat ramp operated by the Sabine River Authority. Representatives of TP&W will make the official site visit and tour the route while they are here for the launching of the 3 trails. We will then begin gathering the information for the website and kiosk. The addition of Six Mile gives us a total of 5 paddling trails on Toledo Bend. We are hopeful to have all 5 trails certified by September 2025 for the Bassmaster Kayak Series national bass tournament which will be held on Toledo Bend Reservoir in Sabine County on September 27 & 28, 2025. This is the first time that a Bassmaster Kayak Series has come to Toledo Bend.
- Since we have updated the hotel feasibility study with Source Strategies, we have been sending the updated information to previous contacts that were made earlier for potential hotel developers to let them know about the new development at Sabinetown Park. I have renewed contact with the new representative of Choice Hotels. He made a site visit to Sabine County on May 21. Judge Melton, Don Iles and I met with him and gave him a tour of the area. He is now doing further research on area as a potential site and will be presenting information to potential hotel developers. We continue to send information to other hotel possibilities.
- We have also been submitting similar information to restaurants to try and be better prepared when Sabinetown Park opens. Two restaurants have been contacted to get them interested in looking at Sabine County. After Dairy Queen closed, we recontacted the two groups that have shown interest and submitted information on the Dairy Queen building to one of the interested parties. We will continue to pursue this opportunity as well as looking for other opportunities. We are expecting a site visit from one of the potential restaurants in July 2025.
- Since we no longer have someone updating the website, we are looking at various options to go forward. I have met with several website companies, and we are still in the process of evaluating our options. I have been working with Matt King to take out all the outdated information and updating basic information on the site.
- We were contacted by Texas Department of Agriculture about the possibility of an additional \$250,000 to be added to our \$1 million grant for the amphitheater at Sabinetown Park. We have some deadlines to meet in the next several months to be able to get the award. Our engineering firm will be providing the requested information.
