This project includes construction of a new solid waste collection station with associated site improvements within the Pct. 1 Barn property.

On August 5, 2025 construction bids from seven (7) contractors for the referenced project. A tabulation of Bids is attached and summarized below:

•	B & B Contractors	\$ 358,900.00
•	Crockett Construction	\$ 364,000.00
•	DSP Development	\$ 445,859.18
•	Chance Construction	\$ 497,940.00
•	Accell Construction	\$ 535,769.00
•	GDC Industrial	\$ 572,006.00

The summary of construction responsibilities was set up as follows:

By County:

- Clearing
- Earthwork and Grading
- Purchase and installation of Gravel on the Site
- Purchase and installation of culverts.
- Coordination with the City of Hemphill for electrical service drop

By Contractor:

- All concrete work (retaining walls / slabs, etc.)
- Safety Railing
- Select Fill beneath paving, foundations and within raised drive through paving
- Fencing and Gates.
- Electrical units, controllers, hook-ups, breakers and related for a fully function system.

If the County desires to award the construction from this bid process, we recommend award to SOHO Construction Building LLC in the amount of \$334,505.00.

If the County desires to re-bid the Project with some reductions in scope and content, we will make changes and re-advertise the Project with the desire to reduce construction cost using more County provided construction and reduction in the amount of proposed concrete work.
