## A PETITION BY PROPERTY OWNERS OF SABINE COUNTY, REQUESTING THE COMMISSIONERS COURT TO LOWER THE SPEED LIMIT TO 20 MPH ON Mott Road, Pct 3

Sec. 545.355. AUTHORITY OF COUNTY COMMISSIONERS COURT TO ALTER SPEED LIMITS. (a) The commissioners court of a county, for a county road or highway outside the limits of the right-of-way of an officially designated or marked highway or road of the state highway system and outside a municipality, has the same authority to increase prima facie speed limits from the results of an engineering and traffic investigation as the Texas Transportation Commission on an officially designated or marked highway of the state highway system.

- (b) The commissioners court of a county may declare a lower speed limit of not less than:
- (1) 30 miles per hour on a county road or highway to which this section applies, if the commissioners court determines that the prima facie speed limit on the road or highway is unreasonable or unsafe; or
  - (2) 20 miles per hour:
- (A) in a residence district, unless the roadway has been designated as a major thoroughfare by a city planning commission;

## The road is described as follows:

The road in consideration for **20 MPH Speed Limit Signs** is known as Sabine County Road **MOTT ROAD** (3<sup>rd</sup> class, county maintained). **Mott Road** runs from State Spur 165 south by southeast to Loop 149 and extending a distance of approximately 3685.44 feet or .698 mile.

The parties signed below make application for SPEED LIMIT SIGNAGE of 20 MPH of said road by filing a petition with the Sabine County Commissioners Court on the 28th day of July 2025, at a regular meeting of said Court scheduled for that date.
