FOR STOP SIGNS ON


BAYOU ROAD NORTH AND BAYOU FORK ROAD IN SABINE COUNTY, TEXAS

On March 9, 2026, at 8:30 a.m., the Sabine County Commissioners' Court at its regularly scheduled monthly meeting, public hearing for April 13, 2026, to discuss installing stops signs on Bayou Road North and Bayou Fork Road in Sabine County, Texas.

After discussion and consideration of relevant factors, including the location, width, and conditions of the roads, public safety, the usual traffic on the roads, and other circumstances relating to the roads, and in Regular Session of the Sabine County Commissioners' Court, on April 13, 2026, the Court finds that installing stop signs are necessary for public safety.


IT IS THEREFORE ORDERED, to install stop signs for the named county roads in Sabine County, Texas.

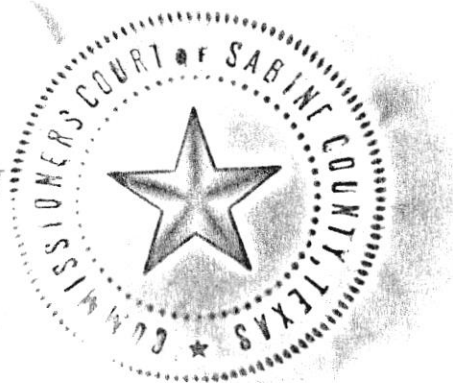

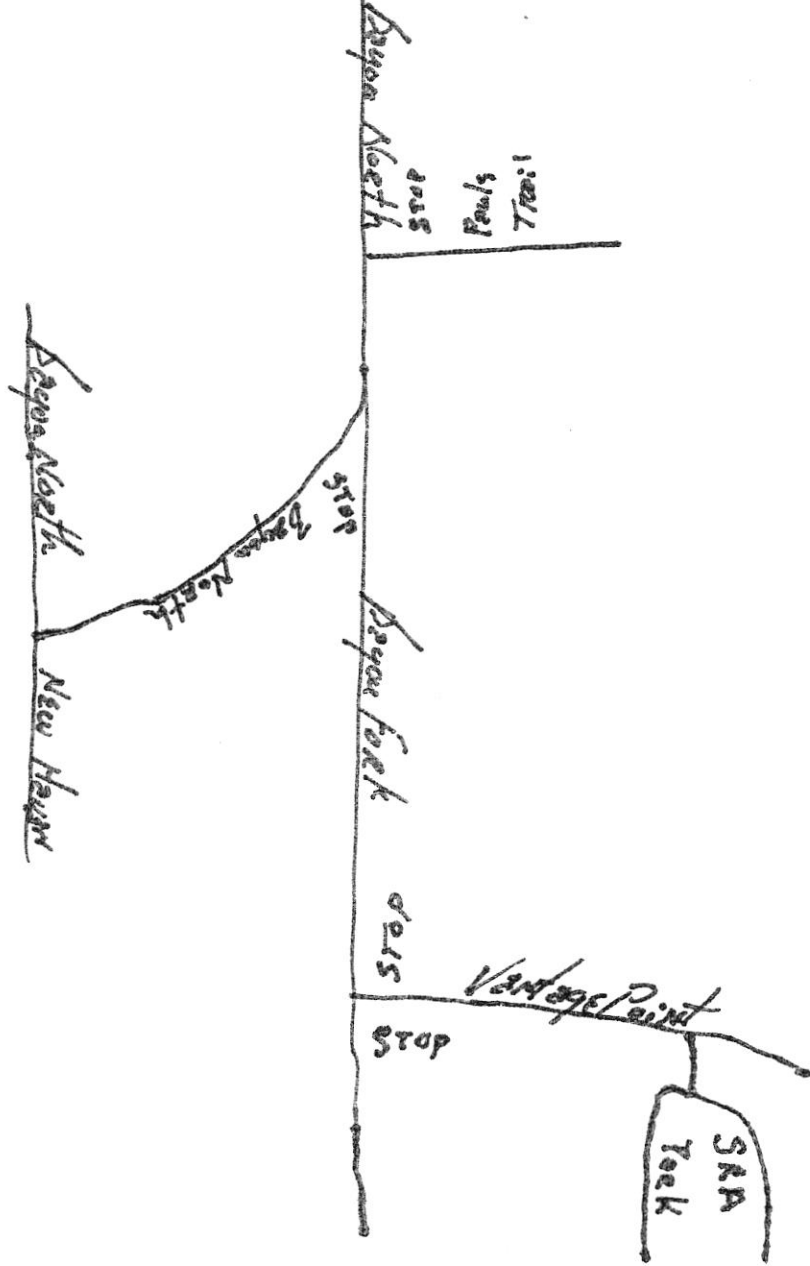
